A quick announcement from the Editors of the Journal of the Association of Environmental and Resource Economists

Last week, all AERE members should have received a paper copy of JAERE's first special issue, "Energy Policy Tradeoffs between Economic Efficiency and Distributional Equity," organized by NBER and funded in part by the Sloan Foundation (thanks!). In case you haven't had time to look at the special issue yet, here is a quick summary.



Economists regularly show that pricing externalities is more efficient than adopting mandates such as fuel efficiency standards, building codes, or renewable portfolio standards. In contrast, policy-makers consistently choose mandates to reduce energy use, perhaps because of the perception that a higher energy price places disproportionate burden on low-income families. Yet papers in this volume often find that mandates are more regressive than energy taxes. They also find large redistributions that are not income related. While this volume is surely not the last word on equity-efficiency tradeoffs in energy policy, its findings can serve as a useful guide to policymakers who wish to avoid inefficiency or adverse distributional consequences.

Now that JAERE is publishing six issues per year, we anticipate being able to accommodate more special issues in the future – perhaps as many as one per year. AERE members interested in proposing a special issue should feel free to reach out to a JAERE editor or co-editor.

A Letter from the Editor of the Review of Environmental Economics and Policy

Dear AERE Members, I have now served as editor of the Review of the Environmental Economics and Policy for just over a year and want to share a few thoughts with members. This also seems an appropriate time to remind our association members of the role that REEP plays within our community of scholarship and perhaps introduce newer environmental and resource economists to the goal and unique positioning of REEP within academic journals and publication venues.

REEP's role in our Profession

As intended from the outset, REEP serves a different function than typical academic journals. Rather than being an outlet for primary research studies as is our premiere research journal, JAERE, REEP is a home for review and synthesis papers. As our web site states "REEP aims to fill the gap between traditional academic journals and the general interest press by providing a widely accessible, yet scholarly, source for the latest thinking on environmental economics and related policy. The Review publishes a range of material including symposia, articles, and regular features." There are three common elements in all that we publish: sound economic reasoning, accessible writing, and relevance.

Visibility and Content

REEP has been consistently ranked in the top-20 of all economics journals and top-15 of all environmental studies journals based on its impact factor (a measure of how the articles in REEP receive citations). This is an important metric for publishers who naturally like to see their journals being actively cited, but more importantly it is an indication that the journal is reaching its goal of providing top quality understandable content to audiences. Further, it is an indication to authors that this is a valuable addition to your publication portfolio: papers published in REEP are well-cited and well-read. REEP has published papers in almost all areas of environmental and resources economics, though not evenly. As I continue to vet papers, I will remain focused on the importance of representing the full suite of environmental issues that our profession addresses.

Types of Papers and Submission Process

Because of the unusual role of REEP in the world of academic journals, our submission process differs from traditional journals. Instead of writing a paper and submitting it once complete, we invite authors to submit short abstracts for a proposed paper and a vita of the author(s). If a proposal is invited for a full manuscript, it is not guaranteed to ultimately be published, and indeed papers are ultimately rejected. However, a strong majority of papers that are invited do, after a full review cycle, prove worthy of publication. In addition to this submission process, the editor and co-editors solicit manuscripts on topics they feel would benefit from a review/synthesis as well as symposium where a group of papers (typically three) are produced on a themed topic. Finally, REEP publishes a variety of Features, shorter pieces that focus on current policy issues and other timely material. Call for Dissertation Awards

Nominations are now being accepted for the Wallace E. Oates Outstanding Doctoral Dissertation Award. Nominated dissertations are judged by a panel of AERE members who emphasize in their deliberations the originality of the research, quality of implementation, expository clarity, and intellectual and practical significance of research findings. Nominees must have completed all the requirements for their doctoral degree by August 15 of the year in which they are being considered for the award, which includes acceptance of the final and complete dissertation by the nominee's university (the degree may be officially conferred in a graduation ceremony at a later date, usually no later than the end of the calendar year). The award is given at the AERE Luncheon and Business Meeting held each year at the Allied Social Science Associations (ASSA) annual meeting in early January. The winner receives a \$1,500 cash award along with a \$500 travel grant to attend a recognition ceremony at the luncheon. The winner's dissertation abstract is also published in the Journal of the Association of Environmental and Resource Economists (JAERE). [Click here to learn more.](#)
